
- Remove Roll Cage hardware and Brace hardware as shown.
- Install Spacer and secure upper portion of Door (B) to Roll Cage with hardware shown.





- Insert Lower Mounting Bracket (F) into Channel.




- Secure lower portion of Door (B) to Lower Mounting Bracket (F) with hardware shown.







- Secure rear portion of Door (B) to Frame with hardware shown.

# Ranger XP® 570 installation



- Install Shoulder Bolt and M8 Sealing Washer to Stricker Bracket, Driver (E).
- Install Stricker Bracket, Driver (E) to Brace with hardware shown.
- Repeat steps for opposite side.
- Before tightening hardware completely, align Doors to machine and ensure that no binding occurs while opening and closing.
